GUIDELINES FOR Ph.D. ADMISSIONS FOR EXECUTIVES FROM INDUSTRY/STATE AND CENTRAL GOVERNMENT ORGANIZATIONS/ SCIENTISTS FROM R&D ORGANIZATIONS/PUBLIC SERVANTS

Preamble:

Jawaharlal Nehru Technological University Anantapur, Ananthapuramu has introduced Ph.D. Program (Full-time/Part-time) for executives from Industry/State and Central Government Organizations/ Scientists from R&D Organizations/Public Servants with an intention to strengthen the Industry-Institution Interaction and also to provide an opportunity for working Professionalsothen than Teaching Faculty with a research flair to pursue Ph.D. Program.

Eligibility Criteria:

- a. Persons working at Executive cadrein the Central & State Government Organizations with at least 55% marks/6.0CGPA in Master's Degree in the concerned discipline and who have 2 years of regular service in the field related to their domain are eligible for admission to the Ph.D. program (full-time/part-time) in their specialization under this scheme.
- b. Persons working as Scientists/ Scientific Officers in the Central & State Government Organizations with at least 55% marks/6.0 CGPA in Master's Degree in the concerned discipline and who have 2 years of regular service in the field related to their domain are eligible for admission to the Ph.D. program (full-time/part-time) in their specialization under this scheme.
- c. Persons working in the Private Organizations/Industries/R&D wings of Private Companies with at least 55% marks/6.0 CGPA in Master's Degree in the concerned discipline and who have 2 years of service in the field related to their domain are eligible for admission to the Ph.D. program (full-time/part-time) their specialization under this scheme.

- d. The Private Organizations/Industries/ Private Companies shall have an annual Turnover of minimum Rs.5.0 Crore in the preceding Financial Year.
- e. MPs/MLAs/MLCs with at least 55% marks/6.0 CGPA in Master's Degree in the concerned disciplineare eligible for admission to the Ph.D. program (Part-time) in core/interdisciplinary subject under this scheme.
- f. Teaching Faculty working in Central Government/State Government/Private Educational Institutions are not eligible to apply under this scheme.

Fee:

The candidates admitted for Ph.D. have to pay an annual tuition fee of Rs.80,000 till the date of submission of Ph.D.thesis.Any other fee applicable shall be paid at the time of Admission.

General Guidelines.

- 1. Admissions of Full-time Ph.D. program under this categorywill be filled only in the constituent colleges/units of JNTUA and Research Centers recognized by JNTUA. However, if a Full Timecandidate joins in any of the recognized research centers of the University, the fee paid by the candidate will be shared in the ratio of **40:60** between the University and the respective Research Centers.
- 2. Admission to the Part-time Ph.D. program under this category will be filled only in the constituent colleges/units of JNTUA.
- 3. The Employers of the candidates admitted under the above category for Part-time Ph.D. program must undertake to relieve the candidate to stay in the campus to enable the candidate to complete the course workand also to sanction leave to the candidate for interaction with Supervisor whenever needed. If it is a Full-time Ph.D. admission, the Employer shall give an undertaking to relieve the candidate for the entire duration of the Ph.D. program till the candidate submits the thesis.
- 4. University will allot aSupervisor to the candidate admitted under Full-time and also under Part-time where the candidate is not having an eligible Supervisor in his/her Organization. However, candidates maybe permitted to have an external supervisor from his/her organization in case of Part-time Ph.D.In such case, the University will allot a Co-supervisor.
- 5. The candidates admitted under this Program are governed by the applicable regulations of the University.
