

INSTRUCTIONS TO THE CANDIDATES

The candidates applying for Ph.D. PROGRAM for INDUSTRY/RESEARCH PROFESSIONALS/PUBLIC REPRESENTATIVES shall carefully read the Instructions and apply only after they satisfy the required criteria.

1. Please read the guidelines and Eligibility criteria thoroughly.
 2. Clearly mention whether you are applying for Full Time or Part Time Ph.D.
 3. Go through the list of constituent units of JNTUA and the Areas of Research available in each unit. Similarly, go through the list of Recognized Research Centers and the Area of Research available at each center.
 4. Fill in carefully the unit name where you want to pursue Ph.D. after thoroughly understanding the guidelines. Any mistake like entering the unit name where your Research Area is not available or selecting Research Center for Part time etc., will result in rejection your applications.
 5. Attach all the copies of necessary certificates failing which your application will be rejected.
 6. Any false information given will make your admission liable to be cancelled if you get an admission based on this information.
 7. Application fee will not be refunded in case of rejected applications.
 8. Candidates have to pay **Rs.5000/-** towards Application Registration fee in the form of Demand Draft in favour of “ **The Registrar, JNT Universtiy Anantapur** ”, payable at **SBI, JNTUEC Branch (Code No.2723), Ananthapuramu.**
- Note: Application Registration fee is non-refundable under any circumstances.**
9. The filled in application along with Demand Draft and photo copies of certificates must be sent to **the Director of Admissions, JNT Universtiy Anantapur, Ananthapuramu through speed post/ courier to reach on or before 04-09-2024 by 5 PM**
 10. The List of photo copies of certificates to be enclosed with the application:
 - a. M.Tech./M.E. certificate
 - b. Marks Memos / Consolidate Marks Memo of M.Tech./ M.E.
 - c. B.Tech./B.E. certificate
 - d. Marks Memos / Consolidate Marks Memo of B.Tech./ B.E.
 - e. SSC certificate
 - f. Last year turnover statement of the company for candidates from Industry/ Private organization
 - g. No Objection Certificate in the requisite proforma
 - h. Salary & service certificate from the working organization
 - i. Publication copies of the applicant
 - j. Concurrence of the Supervisor
 11. Application received after last date notified will not be entertained and no further correspondence will be made in this regard.
 12. University will not be responsible for any delay at any stage. No correspondence / queries will be entertained regarding delays, conduct and reasons for not being called.

13. The University reserves the right not to admit any candidate in any discipline if none is found suitable / eligible.
14. The decision of the University in all matters will be final and binding. No correspondence / interim enquiry will be entertained from the candidates in connection with the process of selection.
15. No accommodation / travel allowance etc. will be provided by the University to the candidates called for admission.
16. Candidates are advised to see the University website regularly for any future updates/ information etc.

PLEASE NOTE:

- i. Candidates should note that their candidature is strictly provisional.
- ii. Candidates should fill the application clearly and legibly. Incomplete applications will be summarily rejected.
- iii. Mode of payment of fee is through Demand Draft only. Fee submitted through any other mode will not be accepted. Fee once paid will neither be adjusted for any subsequent examination nor refunded under any circumstances.
- iv. Application submitted in any other format will be summarily rejected and no correspondence, in this regard, will be entertained. Hence, the candidates are advised in their own interest to apply early enough to ensure timely submission of their applications on or before the closing date.
